

Heller* and *McDonald v. City of Chicago*. The Second Amendment states that [a] well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear arms, shall not be infringed. Before the Supreme Court's 2008 opinion in *Heller*, the Second Amendment had received little Supreme Court attention and had been largely interpreted, at least by the lower federal courts, to be intertwined with military or militia use. Still, there had been ample debate in the lower federal courts and political discussion over whether the Second Amendment provides an individual right to keep and bear arms, versus a collective right belonging to the states to maintain militias, with the vast majority of the lower federal courts embracing the collective right theory. In *Heller*, though, the Supreme Court adopted the individual right theory, holding that the Second Amendment protects an individual right for law-abiding citizens to keep and bear arms for lawful purposes including, most notably, self-defense in the home. Two years later in *McDonald*, the Court held that the Second Amendment applies to the states via selective incorporation through the Fourteenth Amendment. After *Heller* and *McDonald*, numerous challenges were brought on Second Amendment grounds to various federal, state, and local firearm laws and regulations. Because *Heller* neither purported to define the full scope of the Second Amendment, nor suggested a standard of review for evaluating Second Amendment claims, the lower federal courts have been tasked with doing so in the Second Amendment challenges brought before...
